REQUIREMENTS FOR THE DEVELOPMENT OF A HEALTH CLIMATE
EARLY WARNING SYSTEM (H-CLEWS) FOR SAMOA**

The Government of Samoa (GoS) has received financing from the Green Climate Fund (GCF) through UNDP as the GCF Accredited Entity (AE) towards the cost of the Integrated Flood Management to Enhance Climate Resilience of the Vaisigano River Catchment in Samoa ("Vaisigano Catchment Project"), implemented by the Ministry of Finance (MOF) and the National Designated Authority (NDA), and intends to apply part of the proceeds for consulting services/technical assistance.

The GoS through the Ministry of Health ("the Ministry") is seeking to initiate a Health-Climate Early Warning System (H-CLEWS) to address the safety of the residents of Vaisigano Catchment Area, to forewarn and provide adequate lead-time to these communities for preparations and/or evacuation for safety of lives and protection of properties from any impending natural disaster.

The Ministry now invites eligible Individuals or Firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they meet the required qualifications and relevant experience to perform the Services (attach curriculum vitae with description of experience in similar assignments and similar conditions).

The EOIs should be costed but provided in a separate envelope and will be opened only upon completion of technical evaluation based on the ranking.
