# HEALTH CARE WASTE MANAGEMENT COVID-19 EDUCATION TRAINING REPORT

Savaii Trainings: 9 – 11 September 2020

**Upolu Trainings: 15 – 18 September 2020** 

#### 1. BACKGROUND AND CONTEXT:

The World Bank Project in partnership with the Government of Samoa through the Ministry of Health provides capacity building program to improve knowledge and skills of health professionals in the management of health care waste in Samoa.

The World Bank and the Government of Samoa through the Ministry of Health (MoH) continues to place emphasis on helping support the implementation of **Health Care Waste Management Strategic Plan 2020-2025**. Healthcare waste is special in that it has a higher potential of infection and injury than any other type of waste. Therefore it must be handled with sound and safe methods wherever generated. Healthcare waste (HCW) is a by-product of healthcare and generating sources that includes sharps, non-sharps, blood and body parts (anatomical waste), chemicals, pharmaceuticals, medical devices and radioactive materials. Poor management and lack of knowledge on HCW exposes healthcare workers, waste handlers and the community to infections, toxic effects and injuries.

The overarching goal of the Health Care Waste Management is to provide guidance and standards for the management of health care waste as required by the Ministry of Health and the Ministry of Natural Resources and Environment (MNRE) through:

- The minimization of potentially hazardous waste
- Maximize the potential for the recycling of non-hazardous wastes
- Facilitate proper packing and labeling of wastes
- Reduce occupational health and safety risks
- Improve healthcare waste management with in health care institutions and other generating sources.
- To ensure compliance to relevant legislations and policies.

#### 2. TRAINING OBJECTIVES:

- To provide participants with knowledge as to "best-practice" healthcare waste management from point of generation to treatment and disposal. Focus is on environmental and health & safety aspects of healthcare waste management.
- To provide training in the necessary skills and knowledge for "best-practice" healthcare waste management in a train-the-trainer format so participants are competent to deliver healthcare waste training to educate stakeholders as to correct practices.
- Provision of a broad range of resources (copies of procedures, guidelines, training notes and PowerPoint's etc), to assist in the delivery of healthcare waste training and development of best-practice management.

The training program will be undertaken in each District Hospitals/Healthcare Centre/Referral Hospital for both Savaii and Upolu. Resources would also be developed and provided to participants (all health workers).

This training program will address the full chain of responsibility from points of generation through to disposal of treatment residues. The healthcare workers will gain the skills/knowledge to effectively implement healthcare waste management and also train others.

## **Topics covered such as:**

- On-site management (eg., signage, containers, internal collection & equipment)
- Procedures
- Health & Safety (eg., manual handling, PPE)
- Vehicles transporting healthcare waste
- Storage
- Treatment options and management/disposal of residues
- Contingency planning
